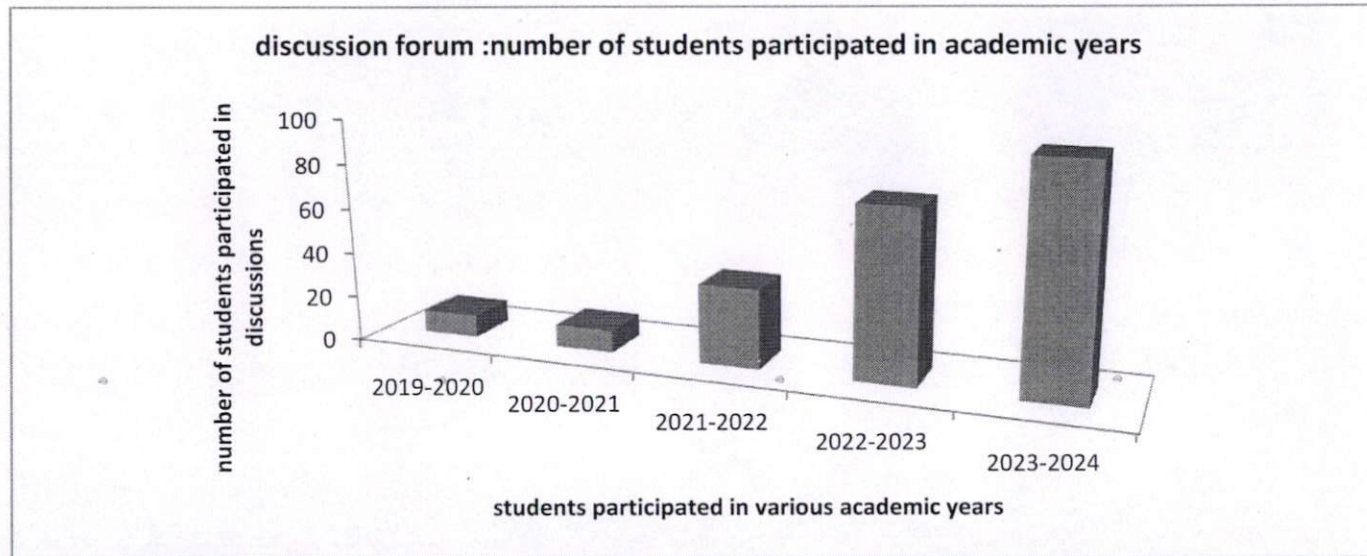


Figure 1. Graphical analysis showing students participated in discussion learning conducted in various academics years from 2019-2024 Figure 1 is a visual representation that illustrates the trend in student participation in discussion-based learning across multiple academic years, spanning from 2019 to 2024.

Student Electoral System: Narayana Pharmacy College

A **student electoral system** is a structured process that allows students to participate in electing their peers to various leadership positions within a school or college. This system is designed to promote democratic values, encourage student involvement in governance, and develop leadership qualities.

ELECTORAL COMMITTEE:

1. The Electoral Committee will consist of 5 members:

- 2 student representatives (elected by students)
- 2 faculty representatives (elected by faculty).

A model electoral system enhances student participation, leadership development. Student government having apex body responsible for student welfare. Elected representative from each class called class representatives from each academic year. A neutral body independent electoral commission (IEC) oversee electoral process. Electoral process was issued by IEC, eligibility criteria for all student candidates given. In this 15 days of designated period for candidates to campaign was allowed, followed guidelines for fair competition. Elections were conducted using a secret ballot system. IEC should oversee the counting of votes and announce the results. Dispute resolution mechanism was established. Suggestion box is a powerful tool to enhance student governance.
